## **ROAD TRAFFIC REGULATION ACT 1984**

The Trunk Roads (A458 and A483) (Welshpool, Powys) (Prohibition and Restriction of Waiting and Prohibition of Loading and Unloading) Order 199

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 1, 2 and 4 of the Road Traffic Regulation Act 1984.

The waiting of vehicles for the purpose of loading and unloading along sides of road specified in the Schedule to this notice has, since July 1991, been prohibited on an experimental basis, between the hours of 8 a.m. to 9.30 a.m. and 4 p.m. to 5.30 p.m. on any day except Sunday. It is considered that the experiment has been successful and the effect of the Order now being proposed will be to continue this

The proposed Order will also revoke and re-enact the provisions of the Trunk Road (A458/A483) (Welshpool, Powys) (Prohibition and Restriction of Waiting) Order 1983 and the Trunk Road (A458/A483) (Welshpool, Powys) (Prohibition and Restriction of Waiting) (Variation) Order 1984, which currently impose a mixture of waiting restrictions on contiguous and adjacent lengths respectively of the A483 and A458 trunk roads.

À copy of the proposed Order and of the Orders being revoked, together with a plan and a statement of reasons for the making of the Order, may be inspected during normal office hours at the offices of Montgomeryshire District Council, Severn Road, Welshpool, Powys during a period of 21 days from 19th December 1992. Copies of the Order may also be obtained, free of charge, from the address, and quoting the reference, below.

Objections, specifying the grounds on which they are made and quoting Ref. ZC 510-2-6-38, must be sent in writing to the Welsh Office, Highways Directorate, Roads Administration Division, Phase 1, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL by 9th January 1993. In the preparation of an objection, and the statement of grounds for objection, it should be borne in mind that the substance of any grounds of objection or representation may be communicated to other people who may be affected by it.
