#### WIRELESS TELEGRAPHY ACT 1949

The Secretary of State gives notice pursuant to sub section 1(4) of the Wireless Telegraphy Act 1949 to all those who are licensed under Amateur Radio (Novice) Licence (A) or (B) which have been issued and remain in force, that, from 1st February 1993, each such licence shall be varied. The Schedule to the Terms, Provisions and Limitations Booklet BR 68 a/N shall be amended as follows:

In column 1 delete "3.565" and substitute "3.560";

In column 1 delete "28.100" and substitute "28.060";

In column 1 delete "50.620-50.760" and substitute "50.0-51.0" and in column 4 against this frequency add "Morse, Telephony" before "Data";

In column 1 delete "51.250-51.750" and substitute "51.0-52.0";

In column 1 delete "433" and substitute "432";

In column 1 add new entry "435.0-440.0" and in column 4 against this frequency band insert "Morse, Telephony, Data, SSTV and FSTV".
