### TOWN AND COUNTRY PLANNING ACT 1990

#### *The Extinguishment of Vehicular Rights (Llanelltyd, Gwynedd) Order 1993*

The Secretary of State for Wales hereby gives notice that, on the application of the Gwynedd County Council, he has made an Order under section 249 of the Town and Country Planning Act 1990 extinguishing, subject to certain exceptions, any rights which persons may have to use vehicles on the length of highway described in the Schedule to this notice.

Copies of the Order and the relevant plan may be inspected during normal office hours at the offices of Gwynedd County Council, Area Office, Cae Panarlag, Dolgellau, Gwynedd, during a period of 6 weeks from 19th February 1993.

If any person desires to question the validity of the Order, or of any provision contained therein, on the grounds:

- that it is not within the powers of the Town and Country Planning Act 1990; or
- that his interests have been substantially prejudiced by a failure to comply with any of the requirements of that Act

he may within 6 weeks of the 19th February 1993 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

Any person, who at the time of coming into force of the Order, has an interest in land having lawful access to the length of the highway to which the Order relates, shall be entitled to be compensated by the Gwynedd County Council as the local planning authority, in respect of any depreciation in the value of his interest which is directly attributable to the Order and of any other loss or damage which is so attributable. Any claim for such compensation must be submitted within 6 months of 19th February 1993.

#### SCHEDULE

(All distances are approximate)

The highway is at Llanelltyd in the county of Gwynedd and is that length of highway, including the area of grass verge, which extends from the southern end of Pont Llanelltyd for a distance of 80 metres in a south-easterly direction. (487)

### HIGHWAYS ACT 1980

#### *The Powys County Council (Newlands, Machynlleth) (Side Roads) Order 1992*

The Secretary of State for Wales hereby gives notice that he has confirmed the above Order which was made by the County Council of Powys under sections 14 and 125 of the Highways Act 1980 and which, as confirmed, authorises the Council:

- to construct new highways;
- to stop up private means of access to premises; and
- to provide new means of access to premises

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1980 or on the ground that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of 19th February 1993, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
