Order

Notice is hereby given that the Minister of Agriculture, Fisheries and Food, in exercise of the powers conferred upon him by section 32(5) and (7) of the Land Drainage Act 1991, proposes to make an Order confirming a Scheme submitted to him by the National Rivers Authority under section 32(1) of that Act. The Scheme makes provision for:

the transfer of the Board's maintenance obligations for drains and a culvert which are now defunct, to new drains.
