*The Stopping-up of Highways (Bryn Road, Mynydd Isa, Clwyd)
Order 1993*

The Secretary of State for Wales hereby gives notice that he has made an Order under section 247 of the Town and Country Planning Act 1990 to authorise the stopping-up of the highway described in the Schedule to this notice to enable development of a residential estate, for which planning permission has been granted, to be carried out.

Copies of the made Order and the relevant plan may be inspected during office hours at the offices of Clwyd County Council, Shire Hall, Mold, Clwyd, or may be obtained, free of charge, on application to the Welsh Office, Highways Directorate, Phase 1, Government Buildings, Ty Glas Road, Cardiff CF4 5PL (quoting ref. ZC 510-5-1-11).

If any person desires to question the validity of the Order, or of any provision contained therein, on the grounds:

- (a) that it is not within the powers of the Town and Country Planning Act 1990; or
- (b) that his interests have been substantially prejudiced by a failure to comply with any of the requirements of that Act,

he may, within 6 weeks of 26th March 1993, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

SCHEDULE

(all distances are approximate)

The highway to be stopped-up is at Mynydd Isa in the county of Clwyd. It is shown by zebra hatching on the annexed plan and is that wedge-shaped area of highway verge, lying on the northern side of Bryn Road, which extends from a point 20 metres west of the junction of Bryn Road and Llewellyn Drive in an easterly direction for a distance of 94 metres.
