HIGHWAYS ACT 1980

The County Council of Durham (A689 Newton Cap Diversion Classified Road) (Side Roads) Order 1992

The Secretary of State of Transport hereby gives notice that he has confirmed with modifications the above Order which was made by Durham County Council under sections 14 and 125 of the Highways Act 1980 and which, as confirmed, authorises the council to:

- (a) improve highways;
- (b) stop up highways;
- (c) construct new highways;
- (d) stop up private means of access to premises;
- (e) provide new means of access to premises.

All on or in the vicinity of the 'classified road' which the Council propose to:

- (a) construct from a point 2 metres west of the western boundary of No. 34 Addison Road in a south-easterly direction by-passing to the north of Toronto Village before crossing the River Wear, utilising the suitably converted former railway viaduct and finally rejoining the existing road A689 at High Bondgate roundabout.
- (b) improve from a point on Road A689, 90 metres west of its junction with Road B6286 in a south-easterly direction to a point 2 metres west of the western boundary of No. 34 Addison Road.

Copies of the Order (as confirmed) and of all the relevant plans may be inspected free of charge at all reasonable hours at the offices of the County Secretary and Solicitor, County Hall, Durham and at Wear Valley District Council, Civic Centre, Crook and at the Department of Transport, Northern Regional Office, Wellbar House, Gallowgate, Newcastle-upon-Tyne.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1980 or on the ground that any requirement of that Act or of any regulations made thereunder has not been complied with in relation to the Order may, within 6 weeks of 23rd April 1993 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
