GWYNEDD COUNTY COUNCIL

The County of Gwynedd (Un-named Narrow Road Leading from Garth Road between Roche Terrace and Marine Terrace, Porthmadog) (Prohibition of Waiting) Order 1993.

Notice is hereby given that on 16th April 1993, the County Council of Gwynedd made an Order under sections 1(1) and (2), 2(1) to 2(3) and 4(2) of the Road Traffic Regulation Act 1984.

The effect of the Order when it comes into force on the 21st May 1993, will be to prohibit vehicles from waiting on the un-named road which leads in a westerly direction from Garth Road between Roche Terrace and Marine Terrace in Porthmadog.

There are limited exceptions, details of which are contained in the Order.

No Waiting in Stockbridge Road, Winchester

Notice is hereby given that Hampshire County Council proposes making a Road Traffic Regulation Order as follows:

The Hartlepool Borough Council (Back Roker Street) (Restriction of Waiting) Order 1993
