HIGHWAYS ACT 1980

The County Council of Avon, Weston-super-Mare Primary Distributor Road, Stages VC and V1 (A370 Classified Road) (Side Roads and other Works) Order 1991.

The Secretary of State for Transport hereby gives notice that he has confirmed with modifications the above Order which was made by the County Council of Avon under sections 14 and 125 of the Highways Act 1980 and which, as confirmed, authorises the Council:

- (a) to construct new highways,
- (b) to stop-up highways, and
- (c) to construct new private means of access

all on or in the vicinity of the route of the Classified Road which means the new length of the A370 classified road from a point 90 metres north-west of the junction of the A370 and West Wick for a distance of 2.5 kilometres in a south-westerly direction to its connection to Stage VB of the Weston-super-Mare Primary Distributor Road (which the Council proposes to construct as part of the Weston-super-Mare Primary Distributor Road) at a point 340 metres south-east of the existing junction of Moor Lane and the A371 at Locking in the district of Woodspring in the County of Avon.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1980 or on the ground that any requirement of that Act, or of any regulations made thereunder has not been complied with in relation to the Order, may, within six weeks of the 6th May 1993 apply to the High Court for the suspension or quashing of the Order of any provision contained therein.
