TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he has made an Order under section 247 of the above Act entitled "The Stopping-up of Highways (Metropolitan Borough of Sandwell) (No. 1) Order 1993" authorising the stopping-up of Whitehall Road, a length of Cambridge Road and a part width of the highway verge at the junction of Oxford Road and Halford's Lane, Smethwick.

The Order as made authorises the stopping-up only to enable the development described in the Schedule to this notice to be carried out in accordance with the planning permission granted to Focus Housing Trust by Sandwell Metropolitan Borough Council on 22nd January 1993 under ref. DC/28316.

The Order provides that the stopping-up must not be carried out until the developer has:

- Carried out the improvement of existing highway along the routes shown cross-hatched on the deposited plan.
