- 1. The gap approximately 520 metres east of the junction of that road with the northern side of the roundabout at Junction 16 on the M1 Motorway.
- 2. The gap approximately 600 metres west of the junction of that road with Northampton Road, Harpole.
- 3. The gap approximately 620 metres east of that junction with that road the B4525, Sandy Lane.
- 4. The gap approximately 980 metres east of the junction of that road with the B4525, Sandy Lane, opposite the entrance to Upton Lodge Cottage.

SCHEDULE 2

U-Turns through the gaps in the Central Reservation which were to be prohibited

PART I

(Westbound Traffic)

1. The gap approximately 1,100 metres east of the junction of that road with the northern side of the roundabout at Junction 16 on the M1 Motorway, and 300 metres east of the Red Lion Public House.

Part II

(Eastbound and Westbound Traffic)

- 2. The gap at the junction of that trunk road with Northampton Road, at Harpole.
- 3. The gap approximately 160 metres east of the junction of that road with the B4525, Sandy Lane, adjacent to South View. (761)
