#### TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he has made an Order under section 247 of the above Act entitled "The Stopping-up of Highways (County of Tyne and Wear) (No. 15) Order 1993", authorising the stopping-up of an area of the unnamed highway leading from Baird Street, Town End Farm, Sunderland, to enable development to be carried out in accordance with planning permission deemed granted under Part III of the above-mentioned Act by Sunderland City Council on 2nd January 1992, under ref. 91/172S.

of 24th May 1993, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

#### **TOWN AND COUNTRY PLANNING ACT 1990**

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 247 of the above Act, which will authorise the stopping-up of the unnamed highway leading from the A688 to the C30 at Wackerfield, Staindrop, County Durham.
