### ROAD TRAFFIC ACTS

### AVON COUNTY COUNCIL

Avon County Council (Various Roads, Clevedon, Congresbury and Yatton Area, District of Woodspring) (Prohibition of Through Heavy Commercial Vehicles of over 7.5 Tonnes Maximum Gross Weight) Experimental Order 1993.

Notice is hereby given that on 24th June 1993, the County Council of Avon made an Order under section 9 of the Road Traffic Regulation Act 1984, as amended, the effect of which is to prohibit any heavy commercial vehicle the maximum gross weight of which exceeds 7.5 tonnes proceeding from any of the roads specified in column 1 of Schedule 1 to this notice to the road specified in relation to the road in column 2 of the said Schedule by travelling along the road specified in relation to that road in column 3 of the said Schedule.

Exemptions are contained in the Order for vehicles to be used for or in connection with the conveyance of goods to or from any premises situated on or adjacent to the road; for fire brigade, police or ambulance purposes and for any vehicle proceeding to or from any premises which are situated on or adjacent to the through route and which are accessible only from that through route.

Objections and representations to this Experimental Order continuing indefinitely, together with the grounds on which they are made, should be sent in writing to the undermentioned address quoting ref. DS/P/6/016 by 20th January 1994. The County Council of Avon will consider in due course whether the provisions contained in the Experimental Order should be continued indefinitely. At that time any objections and comments received will be given consideration. Please note that all representations received may be considered in public by the County Council and that the substance of any representation together with the name and address of the person making it could become available for public inspection.
