PETROLEUM AND SUBMARINE PIPE-LINES ACT 1975

Notice of the Issue of a Submarine Pipe-line Works Authorisation

The Secretary of State for Trade and Industry hereby gives notice that he has decided to issue, and in consequence has issued, a works authorisation to be held by Mobil North Sea Limited, whose address is Mobile Court, 3 Clements Inn, London WC2A 2EB, for the construction of a 12 inch pipe-line and a 3 inch pipe-line between the Excalibur 'EA' Platform and the subsea tee on the Lancelot 'A' to Bacton pipe-lines.

Except with the consent of the Secretary of State, the 12 inch pipe-line shall only be used to convey saturated natural gas, condensate, formation water and inhibitor and the 3 inch pipe-line shall only be used to convey monoethylene glycol and corrosion inhibitor.

The pipe-lines may be used by the holder and with the holder's agreement, and with the consent of the Secretary of State, by other persons.

Phillips Petroleum Company (UK) Limited has been appointed operator of the pipe-lines.
