

## TOWN AND COUNTRY PLANNING ACT 1990

*Proposed Stopping-up of Highways at Blackburn, Lancashire*

The Secretary of State for Transport hereby gives notice that on the application of Atherden Fuller on behalf of Blackburn Rovers Football Club he proposes to make an Order under section 247 of the above Act, which will authorise the stopping-up of lengths of Nuttall Street, Tweed Street and Velvet Street at Ewood, Blackburn.

If the Order is made, the stopping-up will be authorised only in order to enable the development described in the Schedule to this notice to be carried out in accordance with the planning permission granted to Blackburn Rovers Football Club by Blackburn Borough Council on 19th April 1993 under ref. 10.92/1616.
