- (b) to prohibit any vehicle proceeding in Bath Road from entering the exit road from the Bath Road Park and Ride Site:
- (c) to prohibit any vehicle proceeding in a northerly direction in the exit road from the Bath Road Park and Ride Site to make any manoeuvre other than a right turn into Bath Road;
- (d) to prohibit any vehicle proceeding in either of the carriageways of Bath Road at its junction with Emery Road/Stockwood Road from making a 'U' turn so as to proceed in the opposite carriageway in relation to that length of road:
- (e) to prohibit any vehicle proceeding in a westerly direction in the off side lane of the west-bound carriageway of Bath Road upon reaching its junction with the access/exit road to the Bath Road Park and Ride Site to make any manoeuvre other than to continue straight ahead in that lane; and
- (f) to consolidate the existing waiting restrictions in Broomhill Road, Emery Road, Hungerford Road and Stockwood Road (not incuding the length specified in item (a) above). These will remain unaltered on site but will be converted from imperial measurements to the metric equivalent (the conversion will be carried out to decimal places).

NOTE: The access/exit roads to the Bath Road Park and Ride Site referred to in this notice are situated on Bath Road (A4) approximately 240 metres south east of its junction with Stockwood Road and on Stockwood Road approximately 140 metres south of its junction with Bath Road (A4).

Exemptions are provided in item (a) above for any vehicle being used in connection with the carrying out on, or on premises situated on or accessible only from that length of road, of any building operations; the removal of any obstruction to traffic; the maintenance or repair of the road or services therein; in the service of a local authority or water authority in pursuance of statutory powers or duties; Post Office services; boarding or alighting and police, fire brigade or ambulance purposes in an emergency. Any vehicle being used in the length of road specified in Part I above in connection with loading and unloading; taking in petrol, oil, water or air from any garage; weddings or funnerals and in accordance with the current provisions for disabled person's vehicles, except between 7 a.m. and 10 a.m. or between 4 p.m. and 6.30 p.m. Monday to Friday (inclusive).

The County Council of Avon (Stockwood Road, Brislington, City of Bristol) (South Eastern Zone) (Reserved Bus Lane) Order 199 under sections 1(1), 2(1) to (3) and 4(1) of the said Act, the effect of which will be to prohibit all vehicles other than public service vehicles, coaches, pedal cycles, taxis complying with the requirements of the Council of the City of Bristol Byelaws on hackney carriages in respect of roof top signs and emergency vehicles on call in an emergency from entering, proceeding or waiting in that length of the near side lane in the western carriageway of Stockwood Road which extends from 128 metres south of Bath Road northwards for 90 metres.

Exemptions are provided for any vehicle to enter, proceed or wait in the bus lane for the removal of any obstruction to traffic; the avoidance of an accident; access to or egress from off-street loading or garaging; the pursuance of statutory powers or duties or in connection with the supply of gas, water or electricity or of any telecommunication apparatus as defined in the Telecommunications Act 1984 and the boarding or alighting of any person within two minutes. An exemption is also provided for the loading/unloading of goods or merchandise except between 7 a.m. and 10 a.m. or 4 p.m. and 6.30 p.m. on Monday to Friday (inclusive).

Full details of the proposals are contained in the draft Orders, which together with maps, a statement of the Council's reasons for proposing to make the Orders and a copy of the Order to be consolidated may be inspected at the undermentioned offices (callers should report to Reception and ask for the Statutory Orders Section) during normal office hours.
