

CLEVELAND COUNTY COUNCIL

The County Borough of Teesside (Various Roads at Middlesbrough) (Prohibition and Restriction of Waiting) Order 1973 (Amendment) Order 1993.

Notice is hereby given that the County Council of Cleveland propose to make an Order under the Road Traffic Regulation Act 1984.

The effect of the Order will be to amend the County Borough of Teesside (Various Roads at Middlesbrough) (Prohibition and Restriction of Waiting) Order 1973 as follows:

1. By deleting from Schedule 3 to the Order the restriction of waiting between 8 a.m. and 9.30 a.m. and 4.30 p.m. and 6 p.m. on the following lengths of road:
 - (i) *The Crescent*, from its junction with *The Avenue* in a south-westerly direction for a distance of 26 metres.
 - (ii) *The Avenue*, from a point 36 metres south of its junction with *Cumberland Road/Devonshire Road* to a point 29 metres south-easterly of its junction with *The Crescent*.
2. By adding to Schedule 3 to the Order the restriction of waiting between 8 a.m. and 9.30 a.m. and 4.30 p.m. and 6 p.m. on the length of *The Avenue*, Middlesbrough from a point approximately 36 metres south of its junction with *Cumberland Road/Devonshire Road* for a distance of approximately 46 metres in a southerly direction.
3. By adding to Schedule 1 to the Order the prohibition of waiting at any time on the following lengths of road:
 - (a) *The Crescent*, both sides, from its junction with *The Avenue* to a point approximately 132 metres north of the northern kerb-line of *Cornfield Road*, Middlesbrough.
 - (b) *The Avenue*, both sides, from a point approximately 82 metres south of the southern kerb-line of *Cumberland Road/Devonshire Road* to a point approximately 114 metres north-west of the north-western kerb-line of *Lancaster Road*, Middlesbrough.

A copy of the Order together with a plan showing the lengths of road concerned may be inspected, free of charge, at the offices of the County Secretary, Municipal Buildings, Middlesbrough.

If you wish to object or make any representation to the Order you should send the grounds on which it is made, in writing to the undersigned, no later than 6th September 1993.

COVENTRY CITY COUNCIL

*(a) City of Coventry (Foleshill Road/Longford Road/Bedworth Road) (Urban Clearway Revocation) Order 1993**(b) City of Coventry (Longford Road) (Prohibition and Restriction of Waiting and Revocation) Order 1993*

Notice is hereby given that the above Orders, made on 9th August 1993 become operative on 16th August 1993 and have effect as described in *The London Gazette* on 20th May 1993, Issue No. 53308 Ref. 801.

This Order has been amended to that originally proposed in that waiting is prohibited between 7 a.m. and 9 a.m. and 4 p.m. and 6 p.m. and restricted to 30 minutes in any hour between 9 a.m. and 4 p.m. on Monday to Saturday on the east side of Longford Road from a point 70 feet north of its junction with Hurst Road to a point 185 feet south of its junction with Hollybush Road. This represents a reduction in the prohibition of waiting previously proposed.

Copies of the Orders may be inspected at the Council House (Room 56) during normal office hours.

Any person wishing to question the validity of the Orders or of any of their provisions on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1984 (as amended) or that any requirement of that Act, has not been complied with may, within 6 weeks from 9th August 1993 make application for the purpose to the High Court.

The County of Devon (Various Streets, Hartland) (Control of Waiting) Order 199
