*The Melton Borough Council (Norman Way and Park Road) (Prohibition of U-turn) Order 1993*

Notice is hereby given that the Melton Borough Council proposes to make an Order under sections 1(1) and (2), 2(1) to (3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984.

When the Order comes into effect it will:

- (1) prohibit vehicles making a U-turn round the five central reservations situate on the length of Park Road and Norman Way, Melton Mowbray, from Park Road's junction with Wilton Road/Nottingham Road to a point on Norman Way 14 metres to the east of its junction with St. Mary's Way; and
- (2) permit vehicles to turn right on to Norman Way when leaving Nottingham Street.

## MELTON BOROUGH COUNCIL

*The Melton Borough Council (High Street) (Prohibition of Traffic, One-Way and Prohibition of Waiting) Order 1993*

Notice is hereby given that the Melton Borough Council proposes to make an Order under sections 1(1) and (2), 2(1) to (3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984.

When the Order comes into effect it will prohibit vehicles from proceeding and waiting in the lengths of road specified in Schedule 1 and Schedule 2 hereto.

Exceptions in the Order to the length of road specified in Schedule 2 permit vehicles to proceed and wait for certain purposes including (1) repair and maintenance work, (2) loading and unloading goods except between the hours of 10 a.m. and 4 p.m. on any day, (3) access to premises situated in the length of road except between the hours of 10 a.m. and 4 p.m. on any day, (4) access to and egress from Wilton Place and any unadopted parking area situate off the length of road specified in Schedule 2.

Exceptions in the Order to the length of road specified in Schedule 1 permit vehicles to proceed and wait for certain purposes including (1) repair and maintenance work, (2) loading and unloading goods except between the hours of 10 a.m. and 4 p.m. on any day, (2) access to premises situated in the length of road except between the hours of 10 a.m. and 4 p.m. on any day.

The Order will also prohibit vehicles proceeding in the length of road specified in column 1 of Schedule 3 hereto in a direction other than that specified in relation to that length of road in column 2 of Schedule 3 hereto.

Full details of these proposals are in the draft Order which, together with a copy of an Order to be revoked, a map and statement of the Council's reasons for proposing to make the Order, may be examined at the Melton Borough Council Offices, The Borough Secretary & Clerk's Department, Nottingham Road, Melton Mowbray, Monday to Friday, during normal office hours.

## NORFOLK COUNTY COUNCIL

*The Norfolk County Council (North Walsham) (Prohibition of Left and Right-Hand Turns) Order 1993*

Notice is hereby given that the Norfolk County Council has made an Order under the Road Traffic Regulation Act 1984, the effect of which will be to prohibit any vehicle from turning left into Cromer Road from Aylsham Road, and turning right into Cromer Road from Mundesley Road.
