### NATIONAL RIVERS AUTHORITY—ANGLIAN REGION

#### Notice of application to vary a licence to abstract water

Take notice that F. Smith & Sons of 190 Oilmills Road, Ramsey Mereside, Huntingdon, Cambridgeshire, is applying to the National Rivers Authority to vary licence serial number 6/33/53/S/473 to abstract water from the River Nene (old course) and drains of the Ramsey 2nd (Stocking Fen), the Ramsey 4th (Middlemore), the Ramsey 5th (Lodes End) and the Whittlesey Internal Drainage Boards at 18 points in the parish of Ramsey, in the district of Huntingdonshire, in the county of Cambridgeshire. The variation being applied for is to increase the areas of land on which water abstracted at N.G. references as follows may be used as spray irrigation: any point between TL 279 879 and TL 282 877, any point between TL 284 884 and TL 286 873 and any point between TL 287 884 and TL 289 885.
