SCHEDULE

The boundaries of the Conversation Area are described as follows:

In the west, the boundary of the Conservation Area runs along the southern, western and northern sides of the land comprising the children's play area and the village car park. Along the northern side of the car park the boundary follows Goddard Lane and continues north-eastward until it reaches Poplar Terrace. It then leaves the lane and follows the side and rear curtilage of the terrace. It passes behind Poplar Farm and continues the line of the rear wall of the farmhouse across the farmyard to the public footpath which returns the boundary to Goddard Lane. It crosses the lane and runs south-east along the rear curtilage of buildings attached to Anderton House and other properties which front Chapel Street. The boundary then turns north-east, along the boundary wall of Field No. 3223, parallel to the public footpath. At the corner of the field, it turns south-east, crosses the stream and encircels woodland in Field No. 3624 before returning to the stream's eastern bank. It follows the stream south and south-west, before re-crossing the stream and running north between Fields No. 3113 and 2207 to the west of the White House. On joining the lane, it follows it south-west, and leaves the lane in a southerly direction to encompass a barn, now used as a garage. It then crosses the lane and runs north-west along the western edge of Field No. 2420 until it reaches the corner of the children's play area.
