HIGHWAYS ACT 1980

The Cardiff-Glan Conwy Trunk Road (A470) (Pentrebach-Cefn Coed Diversion) Order 1993

The Cardiff-Glan Conwy Trunk Road (A470) Pentrebach-Cefn Coed Diversion Side Roads) Order 1994

The Secretary of State for Wales hereby gives notice that he has made the following Orders:

1. An Order under sections 10 and 12 of the Highways Act 1980 providing:

(a) that a trunk road about 7.84 kilometres in length which he proposes to construct commencing at a point about 55 metres south-west of the trunk road at Pentrebach roundabout and going in a northerly direction to a point on the trunk road (A470) about 120 metres south-east of the junction of the trunk road with the access to The Barn at Dan-y-Darren, north of Cefn Coed, in the County of Mid Glamorgan, shall become a trunk road as from the date when the Order comes into force, and

(b) that length of the Cardiff-Glan Conwy Trunk Road to be superseded shall cease to be a trunk road from the date on which notice is given by him to the County Council of Mid Glamorgan (who will become the highways authority for that length), that the said new trunk road is open for through traffic.

2. An Order under sections 12, 14 and 125 of the Highways Act 1980

(a) authorising him:

- (i) to carry out the improvement of highways;
- (ii) to stop-up highways;
- (iii) to construct a new highway;
- (iv) to stop-up private means of access to premises; and
- (v) to provide a new means of access to premises.

All on or in the vicinity of the route of the above mentioned new trunk road; and

(b) provide for the transfer of the said new highway to the County Council of Mid Glamorgan as from the date on which he notifies the Council that the new highway has been completed and is open for through traffic. Copies of the made Orders and of the relevant plans, may be inspected, free of charge, at all reasonable hours, from 20th January 1994 to 3rd March 1994, at the offices of Merthyr Tydfil Borough Council, Civic Centre, Merthyr Tydfil; The Post Offices at 35 Chapel Street, Abercanaid; 2 John Street, Merthyr Tydfil; 62A High Street, Cefn Coed; and at The Welsh Office, Highways Directorate, Phase I, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL. Any person aggrieved by these Orders and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the Highways Act 1980 or on the ground that any requirement of that Act, or of regulations made thereunder, has not been complied with in relation to the Orders may, within 6 weeks from 20th January 1994 or within 6 weeks from the date of publication of this Notice, if such period shall expire later, apply to the High Court for the suspension or quashing of the Orders or of any provision contained therein.

ROAD TRAFFIC REGULATION ACT 1984

The Trunk Road (A55) (Pen-y-Clip Section, Gwynedd) (De-Restriction) Order 199
