

- (ii) the improvement of the A428 Trunk Road at Lavendon in the Borough of Milton Keynes in the county of Buckinghamshire;
- (iii) the execution of works in connection with the construction and improvement of highways and, the execution of other works mentioned above; and
- (iv) use by the Secretary of State in connection with such construction and improvement of highways and the execution of other works mentioned above.
