TOWN AND COUNTRY PLANNING ACT 1990

The Diversion of Highways (Church Road, Caerau, Cardiff, South Glamorgan) Order 1994

The Secretary of State for Wales hereby gives notice that he has made an Order under section 247 of the Town and Country Planning Act 1990, to authorise the diversion of the highway described in the Schedule to this notice to enable the development of residential properties, for which planning permission has been granted, to be carried out.

The Order requires the provision of a new highway as the diversion, which will be maintainable at the public expense and for which South Glamorgan County Council will be the highway authority.

Copies of the made Order and the deposited plan may be inspected at the Ely Library, Grand Avenue, Ely, Cardiff, between the hours of 10 a.m. to 1 p.m. and 2 p.m. to 7 p.m. on Mondays; 10 a.m. to 1 p.m. and 2 p.m. to 6 p.m. Tuesday to Friday and 9 a.m. to 1 p.m. and 2 p.m. to 5 p.m. on Saturday; during a period of 6 weeks from 3rd February 1994.

If any person desires to question the validity of the Order, or of any provisions contained therein, on the grounds:

- (a) that it is not within the powers of the Town and Country Planning Act 1990; or
- (b) that his interests have been substantially prejudiced by a failure to comply with any of the requirements of that Act,

he may within 6 weeks of 3rd February 1994, apply to the High Court for the suspension or quashing of the Order or of any provisions contained therein.

SCHEDULE

(All distances are approximate)

The length of highway to be diverted is at Caerau, Cardiff, in the county of South Glamorgan. It is that length of highway known as Church Road, including the adjacent verge but excluding the private means of access, which extends from a point 28 metres south of its junction with Heol Carnau for a distance of 183 metres in a general south-easterly direction. ROAD TRAFFIC REGULATION ACT 1984

The A55 Trunk Road (Pen-y-Clip Section, Gwynedd) (One-way Traffic) Order 1994

Notice is hereby given that on 24th January 1994, the Secretary of State made the above Order which will come into operation on 14th February 1994.

The effect is as stated in notice 487 in *The London Gazette* No. 53411 dated 26th August 1993.

Anyone wishing to question the validity of the Order or of any of its provisions on the grounds that it is not within the powers of the relevant section of the Act or that any requirement of that Act or any Instrument made under it has not been complied with, may, within 6 weeks of 3rd February 1994, apply to the High Court for this purpose.

A copy of the Order, any map, may be inspected during normal office hours at the offices of Aberconwy Borough Council, Council Offices, Bodlandeb, Conwy, Gwynedd, during a period of 6 weeks from 3rd February 1994. (486)
