## **ROAD TRAFFIC REGULATION ACT 1984**

The A63 and A6120 Trunk Roads (Austhorpe, Leeds) (40 m.p.h. Speed Limit) Order 199

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 84(1) and (2) of the Road Traffic Regulation Act 1984.

The effect of the Order will be to impose a 40 m.p.h. speed limit on a length of the A63 Trunk Road (Selby Road) at Austhorpe in the district of Leeds (West Yorkshire) from its junction with the A6120 Trunk Road (Leeds Outer Ring Road) to a point 300 metres east of its junction with the eastern kerb-line of the realigned Bullerthorpe Lane, a distance of approximately 1,050 metres. The Liverpool-Leeds-Hull Trunk Road (A63) (Austhorpe, West Yorkshire) (50 m.p.h. Speed Limit) Order 1985 which imposed a 50 m.p.h. speed limit on a stretch of the above-mentioned length of road will be revoked. As the proposed Order if made will also affect the Trunk Roads (40 m.p.h. Speed Limit) (No. 15) Order 1981 which imposed a 40 m.p.h. speed limit on a length of the A6120 Trunk Road and on a short length of the A63 Trunk Road this latter mentioned Order will also be revoked but the speed limit of 40 m.p.h. will be reinstated and incorporated in the proposed Order.

## **HIGHWAYS ACT 1980**

The A406 Trunk Road (Golders Green Road/Brent Street Junction Improvement, Trunk Road) Order 1994

The A406 Trunk Road (Golders Green Road/Brent Street Junction Improvement, Side Roads) Order 1994

The Secretary of State for Transport hereby gives notice that he has made the following Orders:

- 1. An Order under sections 10 and 41 of the Highways Act 1980, entitled the A406 Trunk Road (Golders Green Road/Brent Street Junction Improvement, Trunk Road) Order 1994, which provides that the road which he proposes to construct is at Golders Green in the London Borough of Barnet and is about 455 metres in length. It starts from a point 186 metres south of the junction of the trunk road (Brentmead Place and the North Circular Road) with Golders Green Road and Brent Street, extends generally northwards to end at a point 269 metres north of that junction, and shall become a trunk road as from the date when the Order comes into force.
- An Order under sections 12, 14 and 125 of the Highways Act 1980. in relation to the A406 Trunk Road and the new trunk road to be constructed by him at Golders Green in the London Borough of Barnet. This Order is entitled the A406 Trunk Road (Golders Green Road/Brent Street Junction Improvement, Side Roads) Order 1994 and it:
  - authorises him to:
    - (a) improve highways,
    - (b) stop up highways,
    - (c) construct new highways,
    - (d) stop up private means of access to premises, and
    - (e) provide new means of access to premises, all in the vicinity of the new trunk road; and
  - (2) provides for the transfer of each new highway, except for that to be constructed for temporary purposes, to the Council of the London Borough of Barnet as highway authority from the date on which he notifies them that they have been completed and are open for traffic.

Any person aggrieved by an Order mentioned in this notice who desires to question its validity, or the validity of any provision in it, on the ground that:

it is not within the powers of the Highways Act 1980, or (b) any requirement of that Act or of regulations made under that Act has not been complied with in relation to that Order,

may apply to the High Court within 6 weeks from the date of first publication of this notice. On such an application, the Court may suspend or quash that Order or any provision in it.

(a) that a demand exists or is likely to arise for the conveyance of gas of, or of a kind similar to, the kind specified in the notice

relating to a proposed pipeline; and
(b) that the routes along which the gas will require to be conveyed will severally be, as to the whole or any part thereof, the same or substantially the same as the route or any part of the route so

- (a) an indication in respect of the gas for the conveyance of which a demand may exist or be likely to arise, of
