*Birmingham City Council (Kingsmere Close etc, Erdington)
(Traffic Regulation) Order 1994*

Notice is hereby given that on 2nd February 1994, the above-named Council made the above-named Order under sections 1(1), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 as amended ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act the effect of which, is as follows:

To introduce 'no waiting at any time' in certain lengths of *Kingsbury Road, Kingsmere Close and Lyndhurst Road.*

To introduce 'prohibition of driving' in that length of service road accessed from the Kingsbury Road/Wheelwright Road junction and shown coloured black on the plan.
