TOWN AND COUNRY PLANNING ACT 1990

The Stopping-up of Highways (Nursery Industrial Estate, Chepstow, Gwent) Order 1994

The Secretary of State for Wales hereby gives notice that he has made an Order under section 247 of the Town and Country Planning Act 1990 to authorise the stopping-up of the highway described in the Schedule to this notice to enable development of a supermarket and associated car park, for which planning permission has been granted, to be carried out.

It should be noted that the made Order has been modified from the advertised draft which had proposed that the length of highway to be stopped up should extend from its junction with Station Road.

Copies of the made Order and the deposited plan may be inspected during normal office hours at the area offices of Monmouth Borough Council, High Trees, Chepstow, Gwent during a period of 6 weeks from 10th February 1994.

If any person desires to question the validity of the Order, or of any provisions contained therein, on the grounds:

- (a) that it is not within the powers of the Town and Country Planning Act 1990; or
- (b) that his interests have been substantially prejudiced by a failure to comply with any of the requirments of that Act

he may within 6 weeks of 10th February 1994 apply to the High Court for the suspension or quashing of the Order or of any provisions contained therein.

SCHEDULE

(all distances are approximate)

The length of highway to be stopped up gives access to the Nursery Industrial Estate at Chepstow in the county of Gwent. It is that length of highway, being a cul-de-sac, which extends from a point 10 metres east of its southernmost junction with Station Road in a general northerly direction for a distance of 165 metres.
