(Weight Restriction) Order 1994*

*Birmingham City Council (Shadwell Street City Centre) (One-way
Traffic and Cycle Lane) Order 1994*

Notice is hereby given that the above-named Council propose to make two Orders under sections 1(1), 2(1) to (3) and 3(2) of the Road Traffic Regulation Act 1984, as amended the effect of which will be as follows:

1. To introduce one-way traffic operation in a south-westerly direction in that length of Shadwell Street from a point 35 metres north-east of its junction with St. Chad's Circus Queensway, to its junction with St. Chad's Circus Queensway, and to introduce a contra flow cycle lane along the same length of Shadwell Street, in a north-easterly direction.
2. To prohibit a left turn from Constitution Hill into Summer Lane.
