The A55 Trunk Road (Eastbound Carriageway, Pen-Y-Clip Section, Gwynedd) (Prohibition of Pedestrians) Order 1994

Notice is hereby given that on 17th February 1994, the Secretary of State made the above Order which will come into operation on 28th February 1994.

The effect is as stated in notice 481 in *The London Gazette* No. 53553 dated 21st January 1994.

Anyone wishing to question the validity of the Order or of any of its provisions on the grounds that it is not within the powers of the relevant section of the Act or that any requirement of that Act or any Instrument made under it has not been complied with, may, within 6 weeks of 24th February 1994, apply to the High Court for this purpose.
