## HIGHWAYS ACT 1980 ACQUISITION OF LAND ACT 1981

The Birmingham Northern Relief Road (Wishaw Holly Lane to Curdworth Section) Compulsory Purchase Order (No. WMT ) 100

Notice is hereby given that the Secretary of State for Transport, in exercise of the powers conferred on him by the above-mentioned Acts, has prepared for a draft compulsory purchase order, entitled as above, which he proposes to make, authorising him to purchase compulsorily, the land and rights described in the Schedule hereto for the purpose of:

- (i) the construction of special roads between Wishaw Holly Lane and Curdworth in the borough of North Warwickshire in the County of Warwickshire in pursuance of "The Birmingham Northern Relief Road and Connecting Roads Scheme 199."; and "The M42 Motorway (Dunton Diversion) Scheme 199.";
- (ii) the construction and improvement of highways and the provision of new means of access to premises in the Parishes of Middleton, Wishaw, Curdworth and Water Orton in the Borough of North Warwickshire in the County of Warwickshire in pursuance of "The Birmingham Northern Relief Road (Wishaw Holly Lane to Curdworth Section) Side Roads Order 199." and "The Birmingham Northern Relief Road (Wishaw Holly Lane to Curdworth Section) (Supplementary No. 1) Side Roads Order 199.";

 (iii) the improvement of the A446 Trunk Road at The Belfry and Dunton in the Borough of North Warwickshire in the County of Warwickshire;

(iv) the diversion of watercourses and the execution of other works on watercourses in connection with the construction of special roads, the construction and improvement of other highways and the execution of other works mentioned above;

 (v) use by the Secretary of State in connection with the construction and improvement of highways and the execution of other works mentioned above;

(vi) mitigation of adverse effects which the existence or use of certain of the highways proposed to be constructed or improved by him as mentioned above will have on the surroundings thereof.
