The Stopping-up of Highways (Little Chippenham, Monmouth, Gwent) Order 199

SCHEDULE

(All distances are approximate)

The highway to be stopped up is at Little Chippenham in the county of Gwent. It is shown by thin diagonal lines on the annexed plan and is a wedge shaped area of highway comprising 50 square metres of footway any verge which lies between the south-western side of the former Council Depot Site and a point 1.8 metres north-east of the north-eastern kerb-line of the road known locally as Cattle Market Access Road and extends from the north-west corner of the said site in a south-easterly direction for a distance of 25 metres.
