

District Council on 7th December 1993, under ref. 7/93/0464/DM. The proposed Order will provide that the stopping-up must not be carried out until new highway has been provided and that new highway shall be a highway maintainable at the public expense for which the Durham County Council will be the local highway authority.

Copies of the draft Order and relevant plan may be inspected at all reasonable hours during 28 days commencing on 17th March 1994, at the offices of Sedgefield District Council, Council Offices, Spennymoor, County Durham, and may be obtained free of charge from the Department of Transport (quoting Ref. Any person may object to the making of the proposed Order within the period of 28 days commencing on 22nd March 1994, by notice to the Secretary of State for Transport, quoting the above reference, at the Department of Transport, Northern Regional Office, Wellbar House, Gallowgate, Newcastle-upon-Tyne NE1 4TD.

In preparing an objection it should be borne in mind that the substance of it may be imparted to other persons who may be affected by it and that those persons may wish to communicate with the objector about it.
