##### *The Lincolnshire County Council (Gainsborough - Corringham Road) Prohibition of Waiting Order 1994*

Notice is hereby given, that the Lincolnshire County Council has made an Order under sections 1, 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting at any time on the north side of Corringham Road, Gainsborough between points 34 metres and 71 metres; 93 metres and 123 metres; 146 metres and 186 metres; 228 metres and 288 metres; and 301 metres and 338 metres east of Oak Tree Avenue.

##### *The Lincolnshire County Council (Gainsborough - Lea Road) Prohibition of Waiting Order 1994*

Notice is hereby given, that the Lincolnshire County Council has made an Order under sections 1, 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting at any time on the north side of Lea Road, Gainsborough from a point 18 metres south-east of Withern Court south-eastwards for 60 metres (in the vicinity of the pedestrian refuge).

#### NOTTINGHAMSHIRE COUNTY COUNCIL

##### *The Nottinghamshire County Council (Eastwood Consolidation Area 1) (Eastwood Town Centre) Traffic Regulation Order 1994 (5011).*

Notice is hereby given that the Nottinghamshire County Council has made an Order under sections 1, 32 and 35 of the Road Traffic Regulation Act 1984, as amended, the effect of which will be (in respect of roads at Eastwood in the Borough of Broxtowe):

To impose: Prohibition of waiting by vehicles; one-way traffic; no right turn; mandatory left turn; bus stop clearways.

Any person wishing to question the validity of the Order (which was made on 9th March 1994) or any of the provisions contained in it on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act or any Instrument made under it, has not been complied with in relation to the Order may, within 6 weeks from 9th March 1994, apply to the High Court for this purpose.

Retail development has necessitated further traffic regulation in this area.

The Order will come into force on 5th April 1994.
