Extensions to Ropley Conservation Area

Notice is hereby given that the District Council of East Hampshire in pursuance of powers conferred on them by section 69 of the Planning (Listed Building and Conservation Areas) Act 1990 have designated further areas and one deletion to the existing Ropley Conservation Area, in Hampshire. Trees already included in any Tree Preservation Orders are not subject to this procedure, but are subject, instead, to the more stringent requirements of the appropriate order.
