The ASS Trunk Road (Nant-y-Faenol Lane, St. Asaph, Clwyd) (Prohibition of Left-Hand Turn) Order 199

The A6119 Trunk road (Brownhill Drive, Blackburn) (40 m.p.h. Speed Limit) Order 19

Notice is hereby given that the Secretary of State for Transport proposes to make an Order under section 84(1) and (2) of the Road Traffic Regulation Act 1984.
