The London-Fishguard Trunk Road (A40) (Fishguard Western By-Pass) Order 199

The London-Fishguard Trunk Road (A40) (Fishguard Western By-Pass, Side Roads) Order 199

The Secretary of State for Wales hereby gives notice that he proposes to make the following Orders:

- (1) An Order under sections 10 and 12 of the Highways Act 1980 providing:
 - (a) that a road about 1.50 kilometres in length which he proposes to construct at Fishguard in the county of Dyfed shall become a trunk road as from the date when the Order comes into force; and
 - (b) that the length of the London-Fishguard Trunk Road to be superseded, shall cease to be a trunk road as from the date on which notice is given by him to the County Council of Dyfed (who will become the highway authority responsible for that length) that the new trunk road is open for through traffic; and
- 2) An Order under sections 14 and 125 of the Highways Act 1980, authorising him:
 - (a) to improve, raise, lower or otherwise alter highways;

 - (b) to stop up highways; (c) to construct new highways;

- (d) to stop up private means of access to premises, and
- (e) to provide new means of access to premises.

all at Fishguard aforesaid, and providing for the transfer of the said new highways to the County Council of Dyfed as from the date on which he notifies the Council that the new highways have been completed and are open for through traffic.

Copies of the draft Orders, and of the relevant plans, may be inspected free of charge at all reasonable hours from 29th April 1994 until 10th June 1994, or within 6 weeks from the date of publication of this Notice, whichever period shall expire later, at the Welsh Office, Highways Directorate, Phase 1, Government Buildings, Ty Glas Road, Llanishen, Cardiff; Dyfed County Council, St. Thomas Green, Haverfordwest; Preseli Pembrokeshire District Council, Cambria House, Haverfordwest, the Library, High Street, Fishguard and Fishguard and Goodwick Town Council, Town Hall, Market Square, Fishguard.

Any person may not later than 10th June 1994 or within 6 weeks from the date of publication of this Notice, if such period shall expire later, object to the making of either of the Orders, by notice to the Secretary of State at the Welsh Office, Highways Directorate, Phase 1, Government Buildings, Ty Glas Road, Llanishen, Cardiff quoting ref. ZB910233-310-1, and stating the grounds of objection. In the preparation of an objection and the statement of grounds of objection, it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.
