SCHEDULE

Length of roads in Penrhyn Bay in the County of Gwynedd

Penrhyn Beach Road East, on both sides from a point 15 metres north-east of the centre line of its junction with Traeth Penrhyn for a distance of 170 metres in a north-easterly direction up to the turning area on the north-easterly side of the road.

Penrhyn Beach Road West, on both sides from its junction with Penrhyn Beach Road East in a north-westerly direction for a distance of 40 metres.

GWYNEDD COUNTY COUNCIL

The County of Gwynedd (Various Streets, Penygroes) (Prohibition, Restriction and Revocation of Waiting) Order 1994

Notice is hereby given that the County Council of Gwynedd proposes to make an Order under sections 1(1) and (2), 2(1) to 2(3), 4(2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.

The effect of the Order will be:

- (a) To prohibit vehicles from waiting at any time on the sides of lengths of roads specified in Part I of the First Schedule hereto.
- (b) To prohibit vehicles from waiting for a period of more than 2 hours between 9 a.m. and 5 p.m., Monday to Saturday (both days inclusive) on the sides of lengths of roads specified in Part II of the First Schedule hereto.
- (c) To revoke Article 5 and the Second Schedule of the County of Gwynedd (Various Streets, Penygroes) (Prohibition and Restriction of Waiting) Order 1985, which prohibits waiting on the sides of lengths of roads specified in Part I of the Second Schedule hereto.
- (ch) To revoke Article 4 and the First Schedule of the County of Gwynedd (Various Streets, Penygroes) (Prohibition and Restriction of Waiting) Order 1985, which restricts waiting on the sides of length of road specified in Part II of the Second Schedule hereto.
- (d) To designate the sides of lengths of roads specified in the first column of Part III of the First Schedule hereto as a parking place for medical practitioners practising from a surgery on or adjoining the said side of length of road.
- (dd) To revoke the present Prohibition and Restriction of Waiting on the sides of lengths of roads specified in Part 1, 2 and 3 of the First Schedule.

Exceptions will permit waiting on the sides of lengths of roads referred to in Part 1 and 2 of the first Schedule for the purpose of:

- (a) picking up and setting down passengers;
- (b) loading or unloading goods;

and where necessary in connection with:

- (c) certain buildings operations;
- (d) the maintenance of the road;
- (e) the supply of gas, electricity, water or other statutory undertakings;
- (f) the exercise of local authority powers and functions;
- (g) the exercise of postal functions;
- (h) fire brigade, ambulance and police purposes;
- (i) and in certain circumstances when the vehicle is a disabled person's vehicle.

PART I

Sides of lengths of roads in Penygroes in the County of Gwynedd shown coloured red on the plan attached hereto.

Victoria Road:

- (i) On its northerly side from its junction with Water Street for a distance of 50 metres in an easterly direction.
- (ii) On its northerly side from a point 95 metres east from its junction with Water Street for a distance of 8 metres in an easterly direction.
- (iii) On its northerly side from its junction with County Road for a distance of 22 metres in an westerly direction.
- (iv) On its southerly side from its junction with Water Street for a distance of 41 metres in an easterly direction.
- (v) On its southerly side from a point 82 metres east of its junction with Water Street for a distance of 18 metres in an easterly direction.

- (iii) On its northerly side from a point 112 metres west of its junction with Water Street for a distance of 28 metres in a westerly direction.
- (iv) On its northerly side from its junction with Maes y Farchnad for a distance of 64 metres in an easterly direction.
- (v) On its southerly side from its junction with Water Street for a distance of 47 metres in a westerly direction.
- (vi) On its southerly side from a point 72 metres west of its junction with Water Street for a distance of 9 metres in a westerly direction.
- (vii) On its southerly side from a point 99 metres west of its junction with Water Street for a distance of 41 metres in a westerly direction.
- (viii) On its southerly side from its junction with Maes y Farchnad for a distance of 70 metres in an easterly direction.

- (vi) On its southerly side from a point 33 metres west of its junction with County Road for a distance of 38 metres in a westerly direction.

Snowdon Street:

- (i) On its northerly side from a point 38 metres west of its junction with Water Street for a distance of 36 metres in a westerly direction.
