TOWN AND COUNTRY PLANNING ACT 1990

The Stopping up of Highways (East Moors Road, Cardiff, South Glamorgan) Order 1994

The Secretary of State for Wales hereby gives notice that he has made an Order under section 247 of the Town and Country Planning Act 1990 to authorise the stopping up of the highway described in the Schedule to this Notice to enable development consisting of a creche/day care nursery, for which planning permission has been granted, to be carried out.

Copies of the made Order and the relevant plan, may be inspected during normal office hours at the offices of South Glamorgan County Council, Conty Hall, Atlantic Wharf, Cardiff, or may be obtained, free of charge, on application to the Welsh Office, Highways Directorate, Phase 1, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL (quoting Ref. If any person desires to question the validity of the Order, or of any provisions contained therein, on the grounds:

- (a) that it is not within the powers of the Town and Country Planning Act 1990; or
- (b) that his interests have been substantially prejudiced by a failure to comply with any of the requirements of that Act, he may, within 6 weeks of 3rd June 1994, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

SCHEDULE

(All distances are approximate)

The highway to be stopped up is immediately east of the eastern footway of East Moors Road at Cardiff in the county of South Glamorgan and is a rectangular shaped area of highway land which extends from a point 45 metres north-west of the north-western
