The Secretary of State for Wales hereby gives notice that he proposes to make an Order under section 247 of the Town and Country Planning Act 1990 to authorise the stopping-up of the highway described in the Schedule to this notice to enable office development, for which planning permission has been granted, to be carried out.

During the 28 days from 8th July 1994, copies of the draft Order and relevant plan may be inspected during normal office hours at the offices of Cardiff City Council, City Hall, Cardiff, or may be obtained free of charge from the address, and quoting the reference shown below.

Within the above mentioned period of 28 days any person may by notice to the Welsh Office; Highways Directorate, Roads Administration Division, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL (quoting ref. ZC 510-5-7-29), object to the making of the Order. In the preparation of an objection it should be born in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.

SCHEDULE

(All measurements are approximate)

The areas of highway to be stopped up are at the Friary, Cardiff, in the county of South Glamorgan. They are situated immediately west of the western curtilage of the property formerly known as Magnet House and comprise:

(i) an irregular shaped area of footway which extends from the inner kerb-line of Greyfriars Road in a northerly direction for a

distance of 21 metres, having a maximum width of 3 metres and a total area of 58 square metres; and
(ii) a wedge shaped area of adjoining footway which extends in a northerly direction for a distance of 7 metres, its maximum width of 0.5 metres being at its northern end and having a total area of 2 square metres. (481)
