

- (b) The Hertsmere Borough Council (Borehamwood) (Disabled Persons Parking Places) Order, 1994; and
 (c) The Hertsmere Borough Council (Borehamwood) (Waiting and Loading Restriction) Order, 1994.

The general effect of the Orders would be to introduce a system of parking control in the streets and lengths of streets in Borehamwood listed in Schedule 1 to this notice. This traffic scheme would include residents parking places, disabled persons parking places and various lengths of double, single and broken yellow line. Residents's vistors would also be catered for. Parking charges would be introduced in the public car parks at Brook Road, Clarendon Road and Furzehill Road, Borehamwood.

The general effect of the Parking Places Order would be to:

- (a) designate parking places for residents (also for use by resident's vistors) in the streets and lengths of streets listed in Schedule 1 to this notice, at which charges may be made by the Borough Council for vehicles authorised by the Order to be left in those parking places;
 (b) provide that residents' permits, bearing the letter "A", "B", "C", "D" and "E" and protective covers would be issued by Hertsmere Borough Council on application being made by any person residing in the streets and lengths of streets listed in Schedules 2, 3, 4, 5 and 6 to this notice respectively to this notice who is the owner of a passenger vehicle (12 seats or less), a goods carrying vehicle, a motor cycle or an invalid carriage;
 (c) provide that resident's vistors permits, bearing the letter "A", "B", "C", "D" and "E" would be issued by Hertsmere Borough Council on application being made by any person residing in the streets and lengths of streets listed in the said Schedule 2, 3, 4, 5 and 6 respectively in respect of a vehicle of a class referred to in sub-paragraph (c) above;
 (d) provide that the charge for the issue of a residents' permit would be £35 and which would be valid for a period of twelve months running from the beginning of the month in which it first becomes valid;
 (e) provide that the charge for the issue of residents' vistors permits would be £10 for a book of forty permits (no charge would be made for the supply of one book of forty residents' vistors permits which are supplied with the issue of a residents' permit referred to in paragraph (c) above);
 (f) provide that the hours of operation would be between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive (except on Christmas Day, Good Friday and Bank Holidays);
 (g) provide that certain other vehicles may wait, free of charge, in certain circumstances, e.g. to allow persons to board or alight (maximum 20 minutes) and vehicles left by specified disabled persons (no time limit).

The general effect of the Disabled Persons Parking Places Order would be for:

- (a) revoke the Schedule to the Hertsmere Borough Council (Shenley Road, Borehamwood) (Disabled Persons Parking Places) Order 1993 insofar as it is contrary to the provisions of this Order;
 (b) designate 12 disabled persons parking places in Shenley Road, Borehamwood as shown in Schedule 7 to this notice;
 (c) provide that the parking places would operate at any time;
 (d) specify that vehicles displaying in the relevant position a disabled person's badge (commonly known as "the Orange Badge") issued by any local authority may be left therein for a maximum period of three hours.

The general effect of the Waiting and Loading Restriction Order would be to:

- (a) prohibit waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle);
 (i) at any time in the streets or lengths of streets specified in Schedule 8 to this Notice;
 (ii) between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive, in the streets and length of streets specified in Schedule 9 to this notice;
 (iii) between 2 a.m. and 3 p.m. on Mondays to Fridays inclusive, in the streets or lengths of streets specified in Schedule 10 to this notice;
 (b) prohibit loading and/or unloading of vehicles at any time in the lengths of streets specified in Schedule 11 to this notice;
 (c) revoke any existing restrictions on waiting by vehicles in the lengths of roads referred to in sub-paragraph (a) above imposed by certain Orders made between 1969 and 1993.

A copy of each of the proposed Orders, of maps indicating the proposals and of the Council's statement of reasons for proposing to make the Orders may inspected during office hours, Mondays to Fridays inclusive, at the Civic Offices, Elstree Way, Borehamwood.
