ROAD TRAFFIC REGULATION ACT 1984

The A19 Trunk Road (Easington) (No Right Turn Through Gap In Central Reservation) Order 1994

The Secretary of State for Transport has made an Order under sections 1(1) and 2(1) and (2) of the Road Traffic Regulation Act 1984, on the A19 Trunk Road in the District of Easington, in the County of Durham.

The effect of the Order which comes into force on 28th July 1994 is to prohibit any vehicle having an operating weight exceeding 17 tonnes, to proceed westwards through the gap in the central reservation from the junction with the unclassified road 36.5.
