The Trunk Road (A470) (Carno, Powys) (Prohibition of Waiting) (Variation) Order 1994

Notice is hereby given that the Secretary of State for Wales has made an Order under sections 1, 2, 4 and 124 of the Road Traffic Regulations Act 1984, which will come into force on 1st August

This Order amends the provisions of the Trunk Road (A470) (Carno, Powys) (Prohibition of Waiting) Order 1989 to take account of the changes in the disabled persons' badge (Orange Badge) Scheme, which increased the period of waiting permitted for vehicles displaying such a badge from 2 to 3 hours.

A copy of the Order and the Order which has been varied, together with a plan may be inspected during normal office hours at the offices of Montgomeryshire District Council, Severn Road, Welshpool, Powys, during a period of 6 weeks from 30th July 1994.

Copies of the Order may be obtained, free of charge, on application to the Welsh Office, Highways Directorate, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL, quoting the reference ZC 510-2-6-54.

If any person desires to question the validity of the Order, or of any provision contained therein, on the grounds that it is not within the powers of the Road Traffic Regulation Act 1984; or that his interests have been substantially prejudiced by a failure to comply with any of the requirements of that Act, he may within 6 weeks of 30th July 1994, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
