*The A487 Trunk Road (Llanllyfnt, Gwynedd) (Prohibition of Waiting) Order 1994*

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 1, 2 and 4 of the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to prohibit waiting at any time (with certain exceptions) on the length of the A487 Fishguard-Bangor Trunk Road (hereinafter referred to as "the trunk road") described in the Schedule to this notice.

Copies of the proposed Order, relevant plan and statement of reasons for the making of the proposed Order may be inspected, free of charge, during normal office hours at the offices of Gwynedd County Council, County Secretary's Department, County Offices,

Caernarfon, Gwynedd during a period of 21 days from 1st August 1994.
