PETROLEUM AND SUBMARINE PIPE-LINES ACT 1975

Notice of the Issue of a Submarine Pipe-line Works Authorisation

The Secretary of State for Trade and Industry hereby gives notice that he has decided to issue, and in consequence has issued, a works authorisation to be held by Shell U.K. Limited, whose registered office is Shell-Mex House, Strand, London WC2R 0DX, and Esso Exploration and Production U.K. Ltd., whose registered office is Esso House, Victoria Street, London SW1E 5JW, for the

construction of a 10 inch pipe-line, an 8 inch water injection pipe-line and chemical injection pipe-lines between the Staffjord Drilling Centre and the Brent Alpha Platform.

Except with the consent of the Secretary of State, the 10 inch pipe-line shall only be used to convey crude oil and gas and the chemical injection pipe-lines shall only be used to convey methanol and corrosion inhibitors.

The pipe-lines may be used by the holder and with the holder's agreement, and with the consent of the Secretary of State, by other persons.
