TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 247 of the above Act to authorise the stopping-up of the whole of Steward Street between Spital Square and the northern side of Brushfield Street, the whole of Nantes Passage, a length of Spital Square and an adjoining length of Lamb Street, a part of the northern footway of Lamb Street and length of the northern footway and a part of the adjoining carriageway of Brushfield Street, London E.1.

If the Order is made, the stopping-up will be authorised only in Order to enable the development described in the Schedule to this notice to be carried out in accordance with the planning permission granted to the Spitalfields Development Group, on 2nd March 1993 under reference TH12901/BG/91/250/MO by the London Borough of Tower Hamlets.

The proposed Order will provide that the stopping-up of Spital Square and the length and part of Lamb Street must not be carried out until the Spitalfields Development Group have provided a new highway maintainable at the public expense, for which the highway authority is to be the London Borough of Tower Hamlets.

The proposed Order will also require improvements to Brushfield Street by widening.
