PETROLEUM AND SUBMARINE PIPE-LINES ACT 1975

Notice of the Issue of a Submarine Pipe-line Works Authorisation

The Secretary of State for Trade and Industry hereby gives notice that he has decided to issue, and in consequence has issued, a works authorisation to be held by Britoil plc whose address is Farburn Industrial Estate, Dyce, Aberdeen AB2 0PB, and Victoria Oilfield Development (UK) Limited whose correspondence address is c/o BP Exploration, Annex C, Room G11, Farburn Industrial Estate, Dyce, Aberdeen AB2 0PB, for the construction of a temporary 6 inch flowline within the Foinaven field development.

Except with the consent of the Secretary of State, the pipe-line shall only be used to convey stabilised crude oil.

The pipe-line may be used by the holder and with the holder's agreement, and with the consent of the Secretary of State, by other persons.

Britoil plc has been appointed operator of the pipe-line.
