NOTICE OF PUBLIC PATH ORDER

TOWN AND COUNTRY PLANNING ACT 1990

The South Brandon Farm Brancepeth Public Footpaths Temporary Diversion (No. 1) Order 1993

Notice is hereby given that the Secretary of State for the Environment in exercise of the powers conferred on him by section 247 of the Town and Country Planning Act 1990, and all other powers enabling him in that behalf, has made an Order entitled the South Brandon Farm, Brancepeth Public Footpaths Temporary Diversion (No. 1) Order 1993, the effect of the Order will be to divert for a period not exceeding 3 years, two lengths of footpath (1) No. 4 starting from a point marked 'A' on the map which is 150 metres south-west of the Weather Hill House, for a distance of 251 metres in a southerly direction to a point marked 'B' on the map on to a new line starting from the said point 'B' on the map running in a north-easterly direction for 180 metres to a point marked 'C' on the map, then in a northerly direction for 151 metres to a point marked 'D' on the map, then in a west-south-westerly direction for 120 metres to the said point 'A' on the map, and (2) No. 5 starting from a point marked 'E' on the map which is 50 metres south of Weather Hill wood for a distance of 311 metres in a southerly direction to a point marked 'F' on the map on to a new line starting from the said point 'F' on the map running in an easterly direction for 88 metres to a point marked 'G' on the map, then in a northerly direction for 226 metres to a point marked 'H' on the map, then in a north-westerly direction for 140 metres to the said point 'E' on the map.

The lines and situation of the existing and proposed alternative highway are shown on the map annexed to the Order. The proposed Order will require the restoration of the diverted lengths of footpaths at the end of the said period.

A copy of the Order and the map contained in it has been deposited at the offices of the Durham County Council and may be inspected free of charge at the Council Offices Room 1/7 County Hall, Durham, during normal working hours, and the offices of Durham City Council, Technical Services Department, Reception, Ruth First House, Claypath, Durham, during normal working hours and at Brancepeth Castle Post Office, Brancepeth, Durham during normal opening hours.

The Order becomes operative as from the date of publication of this notice but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the ground that it is not within the powers of the Town and Country Planning Act 1990, or on the ground that any requirement of that Act or of any regulations made thereunder has not been complied with in relation to the making of the Order he may under section 287 of the Town and Country Planning Act 1990, within 6 weeks from the date of publication of this notice make application for the purpose to the High Court.
