- 2. The effect of the Order is to prohibit vehicles (except for police, fire brigade and ambulance purposes) from entering the area signed by yellow box markings at the junction of the A57 Trunk Road (Manchester Road) with Hulme Road, Denton, if it would become necessary to wait inside it because of the presence of other stationary
- 3. Anyone wishing to question the validity of the Order, or any of its provisions, on the grounds that it is not within the powers contained in the above Act, or any requirements of that Act or any relevant regulations made under it have not been complied with, may apply for the purpose to the High Court before 19th September 1994.

This Order implements article 10.3 of Council Directive 92/65/EEC (laying down animal health requirments governing trade in and imports into the Community of animals, semen, ova and embryos not subject to animal health requirements laid down in specific Community rules referred to in Council Directive 90/425/EEC) by permitting the imports of cats and dogs from another member State without a licence, in certain restricted circumstances.
