Rainow Conservation Area

Notice is hereby given that the Macclesfield Borough Council in pursuance of its powers under section 69 of the Planning (Listed Buildings and Conservation Areas) Act 1990, has designated Rainow Conservation Area.

The Conservation Area has been designated because it is of special Architectural or Historic Interest, the character and appearance of which it is desirable to preserve and enhance.

The Conservation Area covers land at Kerridge End and the Central Area of Rainow. The Peak Park Planning Board has designated a complementary Conservation Area covering adjoining land and land at Ginclough which lies within the Peak Park.

Central Area

To the east, the B5470 forms the boundary of the Conservation Area. In the north the boundary includes Stocks Cottage and then turns east to join Smithy Lane. It then follows Smithy Lane a short distance before turning west and including the former school and joining the B5470.

The boundary then follows the B5470 until Round Meadow where the boundary then leaves the road, passes Lowndes Fold and includes Fields 0594 and 9585, and Tower Hill Cottage. It then includes the buildings at Tower Hill Cottages, Field 7578, Lane Edge, North View, the Cottage and Dale Cottage. It then follows the B5470 and includes the Rising Sun Inn and car park before rejoining the B5470 and the Peak Park boundary.

Kerridge End

The eastern boundary follows that of the Peak Park boundary along the B5470. In the north it crosses the stream and includes the buildings at Brookhouse Farm following the curtilage around the buildings. It then follows the curtilage of buildings at Spring Mount and Springbank Mill and the terrace cottages which front onto the B5470. It then includes the curtilages of Kerridge End House and Cesterbridge House before joining the B5470. It then follows the B5470 to Carlofold Lane. The boundary then turns down Carlofold Lane and then turns north-west to include the curtilages of Cesterbridge Cottages and Kerridge End Cottages. It then follows the B5470 to Brooklands and follows the south-west field boundary of 6023 and 6422 to Bull-Hill Lane and the Peak Park boundary.

The designation of an area has several formal consequences including the control of the demolition of certain buildings, a requirement for consent to development which would not otherwise need permission; the need for consent to carry out works on trees and a requirement to advertise planning applications affecting the character and appearance of the area.

A new bridleway shall be created, to replace the above highway which will commence some 260 metres north of The Vicarage, Vicarage Lane running in a generally easterly direction for some 60 metres turning in a generally southerly direction for approximately 200 metres to terminate at a point some 100 metres north of The Vicarage, Vicarage Lane.
