SCHEDULE

The footway and verge fronting 2 to 12 Flaxpool Close, Moss Side, a length of 38 metres and an approximate width of 4.8 metres.

Flaxpool Close, Moss Side, the area of footway/turning head north of the gable end of 1 to 7 Hollam Walk from the line of the southern gable of 12 Flaxpool Close to the boundary fence of Princess Primary School. An approximate length of 23 metres with an approximate width of 7.5 metres.

Hollam Walk, Moss Side, from Flaxpool Close to Walford Close. An approximate length 38 metres with an approximate width of 1.8 metres.

Exton Walk, Moss Side, the footpath fronting 2 to 16 Exton Walk and extending in an easterly direction to Hollam Walk. An approximate length of 70 metres with the width varying between 1 metre and 3.0 metres.

The un-named footpath to the rear of 31 to 45 Sedgeborough Road, Moss Side, linking Flaxpool Close with Walford Close, an approximate length of 92 metres with a width varying from 1.9 metres to 3.9 metres.

Walford Close, Moss Side, from the line of the rear boundary wall of 45 Sedgeborough Road in an easterly direction to its cul-de-sac end and including the areas of footway and the grassed area extending to the western boundary of Princess Primary School. An approximate length of 60 metres, with a width varying from 14 metres to 15 metres.

Walford Close, Moss Side, the section fronting 2 to 8 Walford Close and including the footpath which extends along the front of 8 to 10 and 12 to 18 Walford Close.

Timwood Walk, Moss Side, from the line of the northern gable of 4 Timwood Walk to a point approximately 2.5 metres south of the southern gable of 8 Timwood Walk, an approximate length of 23.6 metres.

The un-named footpath to the rear of 2 to 10 Walford Close, Moss Side, from Walford Close to the line of the gable wall of 10 Walford Close. An approximate length of 34.8 metres with an approximate width of 2.2 metres.

Footpath fronting 8 to 10 Walford Close, Moss Side, and 9 to 23 Thorncombe Close, Moss Side, and 9 to 23 Thorncombe Close linking Walford Close to Thorncombe Close. An approximate length of 44 metres.

The unnamed footway to the gable of 49 Sedgeborough Road and north of 17 to 23 Thorncombe Close linking Sedgeborough Road to Walford Close to Thorncombe Close link footway. An approximate length of 55 metres.

The unnamed footpath to the rear of 49 to 71 Sedgeborough Road, Moss Side linking Gooch Close to the unnamed footway to the south of the Great Western Inn. An approximate length of 76 metres.

Gooch Close, Moss Side, the area of footway and carriageway immediately adjacent to the gable of 71 Sedgeborough Road from Sedgeborough Road to the line of the gable of 2 Gooch Close. An approximate length of 25 metres and with an approximate length of 5 metres.

The unnamed footpath adjacent to the northern gable of 7 Thorncombe Close, Moss Side, from Thorncombe Close running in a westerly direction to the footpath at the rear of 49-71 Sedgeborough Road. An approximate length of 20 metres.

Westerling Walk, Moss Side, the section fronting 2 to 6 Westerling Walk. An approximate length of 20 metres.

Thorncombe Close, Moss Side, from Gooch Close to its cul-de-sac end. An approximate length of 50 metres and with a width varying from 18 metres to 24 metres.

Westerling Walk, Moss Side, from Thorncombe Close to Maclure Close. An approximate length of 53 metres.

The unnamed footway running between 16 and 18 Westerling Walk, Moss Side linking Gooch Close with Westerling Walk. An approximate length of 20 metres.

Maclure Close, Moss Side, from Gooch Close to its cul-de-sac end including adjacent footways. An approximate length of 62 metres and with a width varying from 9 metres to 20 metres.

Westerling Walk, Moss Side, from Maclure Close to Whitswood Close. An approximate length of 92 metres.

The unnamed footpath running between 42 and 44 Westerling Walk, Moss Side, linking Gooch Close with Westerling Walk and Whitswood Close. An approximate length of 20 metres.

The unnamed footpath running alongside the gable of 50 Triscombe Walk, Moss Side and linking Triscombe Walk to Whitswood Close. An approximate length of 18 metres.

Whitswood Close, Moss Side, the area of footway and parking areas immediately adjacent to 50 Gooch Close and 1 Whitswood Close from the line of the back of the northern footway of Gooch Close to the line of the front elevation of 1 Whitswood Close. An approximate length of 36 metres, with an approximate width of 7 metres.

Whitswood Close, Moss Side, from the line of the front elevation of 1 Whitswood Close to its cul-de-sac end including the adjacent footway and the grassed area extending to Westerling Walk. An approximate length of 80 metres with a width varying from 10 metres to 15 metres.

The unnamed footpath to the rear of 42 to 46 Triscombe Walk, Moss Side from Whitswood Close to the line of the gable wall of 34 to 40 Triscombe Walk. An approximate length of 37 metres.

The unnamed footpath running between the gable of 34 to 40 Triscombe Walk and 42 Triscombe Walk, Moss Side, linking the unnamed footpath to the rear of 42 to 46 Triscombe Walk to Triscombe Walk. An approximate length of 19 metres.

Triscombe Walk, Moss Side, from the line of the gable of 34 to 40 Triscombe Walk in an easterly direction to the line of the easterly boundary of the existing playground. An approximate length of 90 metres.

The unnamed footpath running between the gables of 46 and 48 Triscombe Walk, Moss Side and linking Triscombe Walk to Whitswood Close. An approximate length of 18 metres.
