OPENCAST COAL ACT 1958

Tir-Dafydd Rights of Way Application 1994

Notice is hereby given that the British Coal Corporation in connection with the working of coal by opencast operations propose to apply under section 15 of the Opencast Coal Act 1958, to the Secretary of State for an Order suspending non-vehicular rights of way as described in the Schedule below.

2. Opencast planning permission for the working of the site has been applied for.

3. A copy of the application and of a map showing the rights of way can be inspected at the following locations during normal office hours on Mondays to Fridays from 5th August 1994 to 21st September 1994 (with the exception of 29th and 30th August 1994).

- (i) Dyfed County Council Planning Department, Countryside Section, Lyric Buildings, Queen Street, Carmarthen.
- (ii) Dinefwr Borough Council Planning Department, 30 Crescent Road, Llandeilo, Dyfed.
- (iii) British Coal Opencast Offices, Gilfach Iago Opencast Site, Saron Road, Saron, Ammanford, Dyfed.

4. Alternative rights of way for use by the public during the period for which the Order will be in force will be made available as described in the Schedule below.

5. Written objections, stating the grounds on which objections are made, may be sent by any person to the Secretary of State before 21st September 1994, at the Welsh Office (Legal Division), Cathays Park, Cardiff CF1 3NQ (quoting Ref. CC/22/3/26). If the District Council or County Council in whose area any part of the right of way lies objects and do not withdraw their objection the Secretary of State must arrange a Public Inquiry; if any other person objects and does not withdraw his objection he may arrange a Public Inquiry if he thinks fit.

SCHEDULE

PART 1

Rights of Way to be suspended

1. Parts of Footpath 51/56 in the Community of Llandybie in the Borough of Dinefwr, which commences on the B4556 Pen-y-groes to Llandybie Road south-west of Blaenau Villa, Cae'r-bryn and extends in a general northerly direction via Tir-einion and the ruins of Maes-yr-onen, crossing Footpaths 51/62 and 51/64 to terminate at its junction with Footpath 51/63 west of Blaennantgwynne Farmstead, Pentregwenlais, being those parts which extend firstly from a point approximately 480 metres south of Tir-einion in a northerly direction for approximately 68 metres, and secondly from a point 150 metres north-east of Tir-einion in a general north-easterly direction for approximately 1,180 metres.

2. Part of Footpath 51/57 in the Community of Llandybie in the Borough of Dinefwr, which commences on Footpath 51/56 at a point approximately 190 metres north-north-east of Blaenau Villa, Cae'r-Bryn and extends in a general northerly direction crossing the intersection of Footpaths 51/59 and 51/120 near a bridge over the Afon Lash and continuing northwards to rejoin Footpath 51/56 at the ruins of Maes-yr-onen, being that part which extends from a point approximately 278 metres north-east of the said Blaenau Villa, in a northerly direction for approximately 890 metres to its termination on Footpath 51/56 at Maes-yr-onen.

3. Part of Footpath 51/59 in the Community of Llandybie in the Borough of Dinefwr, which commences near a bridge over the Afon Lash, approximately 390 metres north-east of Blaenau Villa, Cae'r-bryn, and extends in a southerly then general easterly direction to terminate on Footpath 51/0/36 at a point approximately 895 metres south-south-west of Glanmarlais, Home-for-the-Aged, Llandybie, being that part which extends from its commencement near the aforesaid bridge, in a southerly direction for approximately 15 metres.

4. Part of Footpath 51/62 in the Community of Llandybie in the Borough of Dinefwr, which commences on the unclassified public road between the B4556 Pen-y-groes to Llandybie Road and Carmel
