## CUMBRIA COUNTY COUNCIL

## WILDLIFE AND COUNTRYSIDE ACT 1981

*Cumbria County Council (Stainmore) Limestone Pavement Order 1994*

Notice is hereby given, that on 12th August 1994, Cumbria County Council acting under section 34 of the Wildlife and Countryside Act 1981, made the Cumbria County Council (Stainmore) Limestone Pavement Order 1994 designating the land described in the Schedule to the Order and prohibiting the removal or disturbance of limestone on or in it.

The Order (which is set out in the Schedule to this notice) took effect when it was made and has been submitted to the Secretary of State for the Environment. The Order will cease to have effect nine months after it was made unless the Secretary of State previously gives notice that he has considered it and does not propose to amend or revoke it, or that he has amended or revoked it, or that the Authority has revoked it.

Representations about or objections to the Order may be made to the Secretary of State for the Environment, Room 908, Tollgate House, Houlton Street, Bristol BS2 9DJ, before 23rd September 1994.

Such representations or objections should be in writing and should state the title of the Order. In the case of objections, the grounds on which they are made should also be stated.

*Cumbria County Council (Stainmore) Limestone Pavement Order 1994*

Whereas the land described in the Schedule to this Order comprises a limestone pavement which has been notified to Cumbria County Council under section 34(1) of the Wildlife and Countryside Act 1981.

And whereas it appears to the Cumbria County Council that the character or appearance of the said land will be likely to be adversely affected by the removal of the limestone or its disturbance in any way whatever, that the Council ought to order as follows:

Now therefore in exercise of the powers conferred by section 34(2) of the said Act of 1981, Cumbria County Council hereby designates and prohibits the removal or disturbance of limestone on or in the land described in the Schedule to this Order and delineated by a thick black line on the map prepared in duplicate, sealed with the Common Seal of the said Cumbria County Council and marked "Map referred to in the Cumbria County Council (Stainmore) Limestone Pavement Order 1994". One duplicate copy of the map is deposited in the offices of the County Solicitor, Cumbria County Council, The Courts, Carlisle and the other is deposited in the offices of the Secretary of State for the Environment.

This Order may be cited as the Cumbria County Council (Stainmore) Limestone Pavement Order 1994.

## SCHEDULE TO THE ORDER

The Order area lies immediately north of the A66 Trunk road, about 2.5 kilometres east of North Stainmore and 5.5 kilometres east of Brough. The area lies within the North Pennines area of outstanding natural beauty but has no other conservation status.

The site is composed of open pasture fields divided in the centre by a farm track. There is no public right of way across the farmland. The fields lie on a small plateau at 270 metres at the foot of Great Knife. The pavements are open and mainly surrounded by rabbit and sheep grazed grassland. They are clearly visible from the A66 (Trunk Road) and a nearby parking area. The outcrops which form gently sloping sheets are mainly concentrated on the southern portion of the site, while in the northern part the pavements are more scattered. No recent damage to the pavements has been noted.

A wide range of grasses and herbs are found mostly in the grikes and occasionally in the surface solution features of the pavements. An area which has been experimentally fenced from grazing has
